Sealed bids will be received by the CITY OF CHATTANOOGA at their offices in City Hall, Purchasing Department, Suite G13, located at 101 E. 11th Street, Chattanooga, TN 37402, until 2:00 PM EDT, Thursday, July 11, 2024 and opened publicly at said location at that hour. The reading of the bids will begin at 2:00 PM EDT.

PROJECT DESCRIPTION

This project involves the repair and rehabilitation of the Walnut Street Pedestrian Bridge over the Tennessee River in downtown Chattanooga, Tennessee. The total length of the bridge is approximately 2,370 feet, extending from Walnut Plaza at the south end to Frazier Avenue at the north end. The work to be done consists of repair of deficient structural steel elements; sandblasting and re-painting structural steel; replacement of existing electrical, lighting, and camera infrastructure; constructing a concrete platform to house the lighting controls which includes minor excavation; replacement of existing timber deck elements; implementation of pedestrian traffic control; and implementation of erosion prevention & sediment control measures.

PROPOSAL CONTRACTS WILL BE ISSUED UNTIL THE TIME SET FOR OPENING BIDS

A Prime Contractor must prequalify with the Department of Transportation in accordance with Section 54-5-117 of the "Tennessee Code Annotated" and Tennessee Department of Transportation Rule 1680-5-3 prequalification of contractors before biddable proposals will be furnished.

The CITY OF CHATTANOOGA hereby notifies all bidders that a 3% Disadvantaged Business Enterprise (DBE) goal has been set for this project and must be met or exceeded.
