This construction and re-construction of sidewalks on Dooley Street from near Wildwood Avenue to SR40 Inman Street, on SR 40 Inman Street from Gaut Street to Sheppard Street, on Gaut Street from SR 40 Inman Street to Central Avenue, and on Central Avenue from Gaut Street to College Hill Recreation Center. Project also includes drainage improvements, ADA upgrades, retaining walls, curb and gutter, signage, striping, crosswalks, pedestrian signals, and landscaping.
