PROJECT DESCRIPTION

This project includes the widening improvements of Lafayette Road from west of Raccoon Branch on the Fort Campbell Military Reservation to east of Walnut Grove Road. This work includes widening each end of the existing two-barrel slab bridge over Raccoon Branch, grading, storm drainage, curb and gutter, base and pavement for widening and resurfacing existing pavement, striping, signing, and tree planting. The total project length is 0.44 miles.

PROPOSAL CONTRACTS WILL BE ISSUED UNTIL THE TIME SET FOR OPENING BIDS

A Prime Contractor must prequalify with the Department of Transportation in accordance with Section 54-5-117 of the "Tennessee Code Annotated" and Tennessee Department of Transportation Rule 1680-5-3 prequalification of contractors before biddable proposals will be furnished.
