PROJECT DESCRIPTION

This project is located within the City of Lafollette, Tennessee. Work consists of constructing a 2 lane, simple span, structural steel bridge with concrete deck over the CSXT Railroad including roadway approaches to the subject bridge that will tie back to existing Dossett Lane on the west end and Memorial Drive on the east end. The total project length is 0.208 miles.
