National Flood Insurance Program/FIRM Maps: Provides training in the CFS certification program. Topics include a regulatory overview, definitions, flood zone designations, flood study profiles, FIRM flood maps, flood map revision overview, LOMA and LOMR, lowest adjacent grade and lowest floor.

NFIP Regulations and Elevation Certificates: Examines Federal LOMA, LOMR and LOMR- F regulations, other NFIP regulations and citations. Further elaboration of NFIP topics will be provided. Elevation certificates will also be discussed.
