# Tennessee Promise College Coaching and COMPLETE Grant Updates

- **First Year Success Rate of 0 EFC Students (TNP Participants)**
  - **32% Non-TN Promise vs. 44% TNP Non-Coached vs. 74% Coached**
- **\$650k disbursed in Fall 2022 to over 1,800 students**
  - **Avg. Grant \$348**
  - **28% Computers**
  - **25% Transportation**
  - **20% Books/Fees**

# Tennessee Promise and Tennessee Reconnect Legislative Updates

## **SB 2019/HB 2094**

- Allows Tennessee residents who graduate from a high school in a contiguous county in a bordering state to be eligible for Tennessee Promise, making it consistent with HOPE

## **SB 2631/HB 2436**

- Allows students who graduate high school early to be eligible for Tennessee Promise immediately  
(e.g. December 2022 graduate could receive Promise as early as January 2023)

## **SB 2405/HB 2152**

- Expands TN Reconnect eligibility to include 23-year-old students regardless of dependency status
