Legislation Recap





Legislative Requirement



On July 15, 2020, the Tennessee General Assembly passed Senate Bill 1247 (SB 1247) to amend T.C.A. § 49-1-614(k)(4):

- requires the Commissioner to develop a transition plan;
- must address the return of ASD schools no earlier than the 2024–25 school year; and
- must be submitted to the Senate and House of Representatives by January 1, 2021.

Commissioner established an Advisory Group to inform the development of the Plan.



Recap: Framework Purpose

The framework is intended to **facilitate the exit** of individual schools from ASD, either when they exit priority status, reach the ten-year cap, or exit based on other conditions.

It should support the exit of current ASD schools, but it also should be the right framework for future ASD schools' exit.

In alignment with what we heard from this group in the last meeting, not every school is the same, and as such, the transition (or school exit) plan **should not** be a one-size-fits-all plan.

The plan will function as a **template**; some components are universal, where others are more school-specific.

Many of the specific details of the transition will be determined through **collaborative discussions** between ASD, district, parents, and school leadership, with oversight and approval from the department.



•Met with ASD funders to share the plan and receive feedback

•Held a second meeting with operators

•Submitted final framework




Overview of Feedback Implemented

Added more detail on expectations, including explicit instructions for each section


Differentiated family engagement and community engagement milestones

Addressed feedback on milestones and how we measure success




Final Plan Overview




Other Updates





Other ASD/Turnaround Updates



- The Charter Commission remains appellate body for charter schools (includes ASD schools transitioning out of the ASD).
- We began monthly performance conversations with ASD operators in December based on the updated School Performance Framework; they were required to submit improvement plans based on deficiencies.
 - Additional updates to the SPF are expected in summer 2021.
- Due to budget and other uncertainties, we are not filling the State Turnaround Superintendent position at this time; Lisa Settle will continue as Interim ASD Superintendent. We plan on resuming the search in late summer/early fall 2021.
- The department submitted ESSA state plan addendum/waiver to address state legislation passed related to accountability on February 1.
