Title I-A Supplement Not Supplant Methodology School Year 2024-25

Introduction

The Tennessee Public Charter School Commission was established as an independent state entity, serving as the LEA for any public charter school it authorizes. Beginning in the 2020-2021 school year, the commission has the authority to authorize public charter schools on appeal of a local board of education's decision. Allocations provided to each charter school are based on one hundred percent (100%) of state and local funds received by the LEA.

Methodology

The Tennessee Public Charter School passes through all state and local funds, less a 3% authorizer fee, to each charter school in accordance with Tennessee Code Annotated 49-13- 112, the procedures developed by the Department of Education, and State Board rule. Each charter school receives their applicable state and local funding allocation, regardless of whether they are Title I – A served.
