


Invitation to Opt-in



RTS contacts students that may be eligible to receive an Associate's degree. The student must provide electronic consent to share their information from their current four-year institution with the two-year institution they transferred from. The student may choose to accept this and opt in, or decline and opt out.







Ineligible Credits



If a student's total credits at the two-year institution does not meet the school's requirement, RTS will notify the student that they are ineligible for the degree.

Ineligible GPA



If the student's GPA at the two-year institution does not meet the minimum requirement, RTS will notify the student that they are ineligible for the degree.




RTS notifies students that do not meet requirements for an Associate's degree at the two-year institution for this cycle. It also reminds them that they may be invited to participate if eligible in the next RTS cycle.

As of Fall 2018 Cycle: For Pre Opt-in Students

Beginning with the Fall 2018 RTS Cycle, students will have had the option to have opted in to RTS via transfer admissions applications or other means. These "Pre Opt-in" students will receive different notification emails than students who have never opted-in.

Reminder to Pre Opt-in Students

REVERSE TRANSFER
Dear John:
Thank you for transferring to University of Memphis.
Our academic records indicate you could now be eligible to receive your associate degree through <u>Tennessee's Reverse Transfer program</u> . Through this program, your credits from Pellissippi State Community College will be combined with credits earned here to determine if your coursework completes the associate degree. The associate degree you started at Pellissippi State Community College could be awarded to you at no cost while you continue working toward your bachelor's degree here!
You have previously opted into this process on either your community college or transfer admissions application.
As a reminder, your permission allows University of Memphis and Pellissippi State Community College to exchange transcripts and/or request transcripts from any other institution you have attended (including high school) for the purpose of the reverse transfer degree evaluation. Please <u>click here</u> by 1/16/2018 to update your personal and contact information, which may be needed for receiving your diploma.
Although you have already opted in, you do not have to participate and can opt out at any time. <u>Click here</u> before 1/16/2018 if you do not now wish to grant access to your courses and grades at University of Memphis. After 1/16/2018 you may opt out by contacting Pellissippi State Community College.
The confidentiality of your academic history is protected by federal law and your information will not be used for any purpose other than that given by your specific consent agreement. If it is determined that you have not completed all of the requirements for the associate degree at this point, you will be reconsidered next semester as you continue to complete your bachelor's degree.
