Delta Apparel, Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure on August 29, 2024. The company is located at 370 JD Yarnell Industrial Parkway, Clinton, Tennessee 37716. The total number of affected workers is 19. Delta Apparel, Inc. (the "Company") is currently seeking a sale of its business. If the Company is unable to conclude a suitable transaction, the planned closing will be permanent. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on July 2, 2024.

The employees at the facility are not represented by a collective bargaining agreement and do not have bumping rights. The East Local Workforce Development Board rapid response team, employed by the East

Tennessee Human Resources Agency has been notified to coordinate services with the employer and affected employees. The East Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
