SportsClips has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective March 28, 2020. The total number of affected workers is 57. This company is located at 1942 Pinnacle Point Way, Knoxville, TN 37922, 4227 Sam Walton Way, Knoxville, TN 37938, 4829 N. Broadway, Knoxville, TN 37918, 6631 Clinton Hwy, Ste. 103, Knoxville, TN 37921, 719 Louisville Rd., Alcoa, TN 37701, & 7614 Chapman Hwy., Ste. 120, Knoxville, TN 37920. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 6, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The East Local Workforce Development Area rapid response team, employed by the East TN HRA has been notified to coordinate services with the employer and affected employees. The East Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
