Virgin Hotels has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective April 5, 2020. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 21, 2020.

The employees at the facility are not represented by a collective bargaining agreement.
